## PARENT / DANCER CONTRACT FOR PERFORMING GROUPS 2015- 2016 Dance year

I \_\_\_\_\_ agree to participate in CCHH&J Performance Group Class.

By signing this contract I agree to the following:

\_\_\_\_ **I am expected to be on time, be at all assigned Performance Group Classes, rehearsals, all performances, and competitions.** In an emergency an absence must be approved by the director. Family vacations, Saturday school, parties, reunions, club meetings, etc. will not be an approved absence. If you have a contagious illness you must have a doctor's letter. Note taking is expected when you are sick or have a serious injury.

\_\_\_\_ I understand that the school year is from September through August 31<sup>st</sup> and includes the enrollment of a pg level summer clinic.

\_\_\_\_ I am expected to meet my required technique classes appropriate for my level of training assigned by the artistic director.

\_\_\_\_ I am expected to be in proper dance attire specified by the artistic director. Hair must be pulled back and secured properly.

\_\_\_\_ I will learn and execute all choreography expected of me with no hesitation.

\_\_\_\_ I will respect all decisions made by the artistic director.

\_\_\_\_ I will help and encourage everyone to make the production a success. I will be part of the "team". I will respect each and every dancer in all performance classes.

\_\_\_\_ I will always have a positive attitude. I understand that bad behavior is not tolerated. Bad behavior is talking badly about another dancer or artistic director, eye rolling, walking out of the classroom or rehearsal without permission, giving up on combinations or choreography, swearing, or treating others with disrespect.

\_\_\_\_ I understand that any use of drugs and alcohol are grounds for my dismissal. Drug and alcohol use will not be tolerated under any circumstances any time and anywhere.

\_\_\_\_ I will commit to reaching or surpassing my potential with hard work and devotion.

\_\_\_\_ I will follow all rules and etiquette and be professional at all times.

\_\_\_\_ I will meet the expectations of the directors and my audience.

\_\_\_\_ I understand there is a \$160.00 costume and competition fee will be required for each performing group a student is enrolled in. This charge covers ONE COSTUME and TWO COMPETITION entry fees. These fees are due by November 1<sup>st</sup> so that we will make deadlines for competition entry! After November 1<sup>st</sup> there will be a late charge of \$10.00.

\_\_\_\_ I understand that I will be required to purchase a team uniform, outside of my dress code, which I will wear at all pg events and competitions.

\_\_\_\_ *If I do not meet the requirements above the following is necessary:*

**1st time offense-** issued a verbal warning

**2nd time-** asked to leave class, rehearsal, or theatre- letter sent home to parents

**3rd time-** asked to leave class, rehearsal, or theatre- meeting requested with parents- parents and child asked to sign agreement that they understand child is in danger of being dismissed from program without refund.

**4th time-** Student dismissed from Performance Group without refund.
